Custodial Account – Transfer of Ownership Form

Use this form to terminate the custodianship of a UTMA/UGMA, Minor IRA, or Minor Roth IRA account when the minor has reached legal age under appropriate state law. This form is not to be used for Coverdell Education Savings Accounts.

Please include a copy of the former minor’s driver’s license or other government issued identification. A certified copy of a legal document or Medallion Signature Guarantee (MSG) stamp will be required if the former minor’s name has changed or the birthdate does not match the birthdate on file.

Note: When terminating custodianship of a Minor IRA or Minor Roth IRA, the new account registration may only be the same type of IRA in the former minor’s name.

2. Instructions – Complete part A or B

A. UTMA/UGMA custodial account

 - Corporate/Other Entity - A Medallion Signature Guarantee (MSG) Stamp is required on this form.

Medallion Signature Guarantee: An eligible guarantor is a domestic bank or trust company, securities broker/dealer, clearing agency or savings association that participates in a medallion program recognized by the Securities Transfer Agents Association. The three recognized medallion programs are the Securities Transfer Agents Medallion Program (known as STAMP), Stock Exchanges Medallion Program (SEMP), and the Medallion Signature Program (MSP). A notarization from a notary public is NOT an acceptable substitute for a signature guarantee.
